MINUTES OF THE MEETING

WELCOME ADDRESS

The Chairperson welcomed all members to the meeting. She specifically welcomed Dr Hemant Verma, Dy Director, Department of Higher Education, Govt. of Haryana who was attending the meeting for the first time. She thanked all the members for their continued support, and thereafter requested the Member Secretary to proceed with the agenda of the day.

Member Secretary presented the agenda items.

ITEM No. 1: CONFIRMATION OF THE MINUTES OF THE XXXVII MEETING OF BOARD OF MANAGEMENT held on 25 April 2023, circulated by email on 15th May 2023, enclosed as **Annexure** 1, including confirmation and progress on matters arising thereof. (Member Secretary)

Action taken points of the previous meeting held on 25 April 2023 are summarized as under:

Mr. Mehra brought out that The Haryana Pvt Universities Act 2006 and its subsequent amendments prohibit the Private Univs of Haryana from offering programmes in the ODL mode, and the same was not in consonance with the NEP 2020, which aims to make quality education available to the masses at affordable prices through modern education technology, including Open and Distance learning methodology. He brought out that the UGC Distance Education Bureau has laid down stringent quality norms/ criteria for universities to meet, before they can be considered to offer courses in ODL mode. The NorthCap university meets all these criteria, being a NAAC Grade A Univ, yet it cannot get approval of the UGC-DEB, only because the Haryana Pvt Universities Act 2006 and its subsequent amendments do not permit the Private Univs of Haryana to offer programmes in the ODL mode. Whilst on one hand the Department of Higher Education, Govt. of Haryana seeks status of implementation of NEP action points from the private universities every 15 days, which includes efforts undertaken to implement ODL programmes, on the other hand it prohibits them from doing so. Mr. Mehra requested the Govt. of Haryana to reconsider this prohibitive clause, and permit the eligible private universities of Haryana to offer programmes in ODL mode so that there is parity amongst universities all across the country.

The members took note of the above and confirmed the minutes of the 37th Board of Management meeting held on 25th April 2023.

ITEM No. 2: APPOINTMENT OF MR. AVDHESH MISHRA AS CHANCELLOR OF THE NORTHCAP UNIVERSITY.

(Member Secretary)

- 1.The letter received from the Higher Education Department vide Memo No. 776642: DHE-120007/34/2022-UNP (5) dated 03rd August 2023 regarding the appointment of Mr. Avdhesh Mishra as Chancellor of The NorthCap University was taken on record. (Copy of Letter enclosed as **Annexure 2**)
- A) While the letter approved our proposal sent vide our letter dated 19th April 2022, the date of appointment has not been mentioned in the aforesaid letter. NCU has written to the Department of Higher Education vide letter No. NCU/HG/08/11-01/2023 dated 11th August 2023 for a clarification, but no reply letter has been received to confirm the date of appointment.
- B) On 13th February 2023 NCU received a letter from Director Higher Education vide Memo No. 963803 DHE-120007/7/2023-UNP (5) in response to our letter dated 19th April 2022 seeking a clarification on who is working in the position of Chancellor in the University from 21st May 2022 till date. (The final extension date of the Chancellor)
- C) In response thereto, NCU had replied vide letter dated 16th February 2023 stating that pending approval of our letter dated 19th April 2022 and follow up letters dated 09th May 2022, 30th May 2022, 28th July 2022 and 21st November 2022, the current Chancellor Sh. V Daulet Singh continued to discharge the duties of Chancellor.
- D) This extended term of the existing Chancellor ends on 20th May 2023. The same was intimated to Hon'ble Governor vide our letter dated 09th May 2023 with a request to confirm the appointment of new Chancellor on or before 20th May 2023.

E) Since NCU has only now received the approval letter dated 03rd August 2023 (73 days beyond the extended term of the previous Chancellor), the appointment of Mr. Avdhesh Mishra as Chancellor of The NorthCap University has become effective from 03rd August 2023 for a period of 3 years i.e. till 02nd August 2026.

All correspondence relating to the subject is attached herewith as **Annexure 3**.

In view of Mr. Avdhesh Mishra becoming the Chancellor of the university with effect from 03 Aug 2023, reconstitution of the Board of Management, Governing Body and Finance Committee of The NorthCap University became necessary, and is proposed as follows:

The member secretary requested the members of the Board of Management to approve the appointment of Mr. Avdhesh Mishra as Chancellor of the University with effect from 03 August 2023, and the re-constituted Board of Management, Governing Body and Finance Committee of the university.

All Members of the Board of Management took note of the above and approved the same.

ITEM No. 3: ADMISSION UPDATE FOR THE ACADEMIC YEAR 2023-24.

(Head Admissions)

Head Admissions updated the members on the number of students admitted till date and the plan of action for further admissions based on withdrawals / fresh admissions. (Annexure 4) UGC has intimated that the last date of admission for the current academic year is 30th September 2023 (with full fee refund) and 31st October 2023 (after deducting Rs. 1000/- and refunding balance fee).

The following points emerged during the discussions:

- Due to the low enrolment in B.A (Economics), the 06 enrolled students to be counselled to shift to other programme like BBA or B.Com. Mr. Mandeep and Dr. Sona Vikas to take it forward with the students.
- The issue of low admissions in BCA this year, as compared to last year, is a cause of concern. Since the subject of Maths was made compulsory at +2 level as eligibility criteria for BCA this year, the enrolments have dropped.
- Programmes with less than 10 enrolments should not be run from a financial viability point of view.
- The strict selection criteria, Interview & screening process to be continued and quality of students to be checked during admissions through a two level approach viz at the level of admission office to begin with, and then at the departmental level through a panel of faculty constituted for this purpose. Dr Zorawar stated that the number of students 'not approved' by the panel should be noted and the reasons thereof documented, so that the data can be analysed for necessary insight into the efficacy of the procedure, in due course of time.
- Mr. Mehra stated that B.Tech admissions should continue till the last day of admissions, in consultation with Dean Academics.
- Students seeking withdrawal are writing directly to the UGC without informing the University, and the UGC in turn is asking the university to immediately refund the fee. A suitable communication needs to be sent to UGC in this regard that we have not refused refund to anyone.
- The Hon'ble Vice Chancellor suggested that UI/ UX specialisation should be introduced in BCA from next year onwards to increase enrolments.
- Dean Academics brought out that there is a need to re-examine the large number of specializations that are being offered in various programmes, as the same leads to situations wherein a particular specialization has very few admissions, which in turn has associated administrative and academic repercussions. He suggested that we should offer generic programmes, and specializations therein can be incorporated later at an appropriate stage. Mr Mehra directed the Hon'ble Vice Chancellor to review the programmes in line with the NEP 2020 to incorporate flexibility and liberal approach in the matter.
- MA (English) and MA (Psychology) courses to be kept on hold as of now, and to be reviewed next year.
- Mr. Mandeep was requested to enroll students keeping batch size in mind and Dean Academics to monitor this closely.

All members of the Board of Management took note of the above.

ITEM No. 4: ANALYSIS OF SEMESTER RESULT JANUARY - JUNE 2023

(Dy. Dean Examination)

Dy. Dean Examination presented a comprehensive analysis of semester results January – June 2023 session, for all schools during the meeting. Copy of the same is placed at **Annexure 5**.

She brought out that SOM, CLL and BCA have percentage of all clear students below 60% in the current semester which is a matter of concern. She also highlighted that all Schools/ programmes (except M.Tech.) have percentage of all clear students below 60% till current semester. She also highlighted that BCA 4th semester has zero percentage of all clear students till current semester, which again was a matter of serious concern.

Mr. Mehra stated that a Committee needs to be constituted with all HODs and Examination Cell to understand the root cause of such poor results. The Committee to submit a report within 7 days on how to address the present situation of high failure rates, and steps required to be taken to prevent such occurrences in the future. He also stated that the committee should examine the Action Plans of the HODs on how to mitigate the high detention/failure rates.

Mr. Mehra also stated that CLL Dept needs to be in the Committee to understand the gravity of the situation.

He also stated that the course-wise data of all the failed students' needs to be shared with the departments and students' mentors. The action plan submitted by the departments needs to be more concrete, and not generic/ broad based ones. It should also be brought to the attention of parents.

Dr. Rita Chikkara to share the plan of action being followed in CSE Dept, which has shown positive results, with other schools/ departments for their benefit.

Dy. Dean Examination to discuss the course wise failure students with concerned HODs and Hon'ble Vice Chancellor.

It was also discussed that remedial classes should be conducted for students who failed in the 'reappear' exams also, to help them clear the courses. Timetable needs to be formulated for the remedial classes. Students should be made aware that not attending these remedial classes may impact their assessments. Concerned faculty and mentors to ensure that students attend the remedial classes. The parents of such students should also be called through the respective mentors.

All members of the Board of Management took note of the above.

ITEM No. 5: UPDATE ON INTERNATIONAL RELATIONS OFFICE (IRO)

(Dy. Dean - International Affairs)

Dy. Dean International Affairs updated the members on the recent initiatives of the International Relations Office (Annexure 6). She highlighted the immersion programmes undertaken at the Arizona State University, USA, SIT Japan and Univ. of Isa Ungul, Indonesia, where students of NCU participated. She also informed the members about a forthcoming immersion program in December 2023, wherein students of the University of North Florida (UNF) will be visiting NCU.

Mr. Mehra stated that Immersion programmes at NCU need to be planned with other universities as well. In this regard, Dr. Sharda in consultation with Dr. Manoj Gopaliya, to present a plan of action on or before 16th September 2023.

Mr. Mehra also stated that a booklet needs to prepared, bringing out all our international partnerships. Dr. Sharda to have it ready in next 15 days. The booklet should include data in a tabular form, bringing out the number of students who expressed interest in various immersion programmes, and those who finally ended up attending the same.

Mr. Mehra stated that a FAQ for International Relations Office also needs to be brought out, in hard print.

The Hon'ble Vice Chancellor stated that along with UNF, students from Queensland University Australia and SIT Japan should also be invited for the Immersion program at NCU in December 2023.

All members of the Board of Management took note of the above and approved the same.

ITEM No. 6: CHANGES TO FEE STRUCTURE

(Head Admissions)

Head admissions briefed the members about proposed changes in fee structure for the Academic Year 2023-24. With the permission of the Chair, he also briefed the members about changes proposed to the intakes to various programmes for the Academic Year 2023-24. (Annexure 7). He pointed out that the Fee and Intake revision was undertaken to encourage more students to join the university, whilst simultaneously ensuring enrollment of good quality students.

All members of the Board of Management took note of the above and approved the revised Fee structure and Students intake for the AY 2023-24.

ITEM No. 7: CREATION OF CENTRE FOR MEDIA AND ENTERTAINMENT (CME) (HOD - CSE)

Head CSE briefed the members on the functioning and responsibilities of the CME. She also briefed the members about the infrastructure, academic team, software's available and the placement opportunities for students pursuing courses in media and entertainment (Annexure 8)

Mr. Mehra stated that a printed booklet comprising of all information pertaining to CME should be made, and the same can be used as a promotional material.

All members of the Board of Management took note of the above and approved the same.

ITEM No. 8: DISCIPLINARY CASE - EXPULSION FROM UNIVERSITY

(Member Secretary)

One student 21LLB074 Dhruv was involved in adopting unfair means during his major examination on 11 May 2023. Upon examination of the case, it was observed that he had earlier also resorted to cheating during exams. Being a repeat offender, the student was expelled from the University on 19 June 2023. It was brought out that due process, as per university rules and regulations, had been followed in the examination and disposal of the case.

All members of the Board of Management took note of the above and ratified the same.

ITEM No. 9: UPDATE ON LEGAL MATTERS

(Member Secretary)

Member Secretary updated the members regarding all on-going legal cases pertaining to the University.

Punjab & Haryana High Court Chandigarh

1) CWP-22262/2012 Reservation for Haryana Domiciled students and awarding of fee concession.

In the matter relating to Reservation for Haryana Domiciled students and awarding of fee concession, the petition has been listed as per the roster. The matter is clubbed with CWP 6229/2013 and is put as a regular matter. The case was listed for hearing on **21 July 2022**. Copy of the Interim order is enclosed as **Annexure 9.** The matter is now with the Supreme Court. The next date of hearing is not yet listed.

2) CWP-6229/2013 Regulation of Admission & fixation of fee in Private Universities

The University has challenged the Haryana Private Technical Education Institutions, Regulations of Admission of Fee Act 2012, as this act exercises control over admissions and fee through the Fee & Admissions Committee.

The University filed extraordinary writ jurisdiction 13602-13603 dated 07-12-2020, to stay the operation of the Haryana Private Technical Education Institution (Regulation of Admission and Fee) Act, 2012 and memo dated 12-11-2020 and 02-12-2020. This matter is also clubbed with CWP 2644 of 2021.

Last year the University had received a Memo No. 365 / A&FRC dated 07.07.2022 regarding the fixation / revision proposal for the Academic Session 2023-24, (enclosed at **Annexure 10).** Since the matter is sub judice, a reply on behalf of the University, by our legal counsel, was made to the Member Secretary of the Admission & Fee Regulatory Committee (copy enclosed at **Annexure 11).**

This year too, the University has received a similar Memo from Admission & Fee Regulatory Committee, Haryana (Memo no. 206 / A&FRC), dated: 22.03.2023, regarding schedule of submission of fee fixation / revision proposal for the academic session 2024-25, which is enclosed as **Annexure 12**.

All the details were shared with our Legal counsel, who drafted a suitable reply to the Memo dated 22 March 2023, which was then forwarded to the Admission & Fee Regulatory Committee. Copy of the letter sent is enclosed as **Annexure 13.**

Labour Court Gurugram

3) Following case pertaining to Notice Pay is in progress in the Labour Court, Gurugram. Details of these case is given as under:

a) Mr. Trilok Nath, Ex Technical Staff - Non receipt of Notice Period Pay

The individual is not eligible for notice pay, however gratuity to the individual has been paid. He was informed by Labour Officer Mr. Shushil Maan on 29.09.2020 that he should apply "Maang Patra" against the University if he is not satisfied with the reply. We have now received a letter from the Asst. Labour Commissioner, Circle 2, Gurugram, regarding "Maang Patra". Detailed reply has been submitted to the Labour court on 27-01-2021. University has received a Notice for Appearance & Settlement of Issues from the Court of Mr. Amrit Singh (A.D.J.) Presiding Officer, Tribunal-cum-Labour Court-2, Sharam Shakti Bhawan, Near Mini Sectt., Gurugram and the Hearing was scheduled on 01.09.2021. The next date of hearing is awaited.

All members of the Board of Management took note of the progress of the legal matters.

ITEM No. 10: REPORTING MATTERS / INFORMATION POINTS

(Member Secretary)

1. QS-IGauge awards

The NorthCap University proudly received the Diamond Badge in the Overall Category and the Platinum Badge in the Engineering Category at the QS I·GAUGE awards. Prof. Rekha Vig, Professor & Dy. 5. Training Certificate Program

A 2-day Training Certification program was jointly organized by SOM&LS, The NorthCap University & Neofusion Creative Foundation Gurugram on 5-6 May 2023. This program was organized for teachers, counselors, psychologists and psychology students for acquiring a certification to enhance their knowledge in this very relevant area, as well as upskill themselves.

6. Farewell for Batch of 2023

The NorthCap University organized farewell for the final year students of SOET, SOM and SOL on 02 May 2023. The day witnessed heart-warming performances by the Encore Musical Group & Dancescape of the University. It was an atmosphere of joy and excitement, tinged with the expected emotions of bidding farewell to college days.

7. MDP in Partnership with Shri Vishwakarma Skill University (SVSU)

The School of Management and Liberal Studies at NCU, in partnership with Shri Vishwakarma Skill University, Haryana, (SVSU), conducted an engaging 2-day Management Development Programme (MDP) aimed at facilitating a smooth transition for new managers into effective leadership roles. The programme was carefully designed to focus on functional, managerial, and leadership skills necessary for success. Expert facilitators from both institutions delivered effective and engaging training sessions. From personal and interpersonal skills to group skills, all the key areas were explored. The faculty of NCU's School of Law conducted a 1-day workshop on 'The Sexual Harassment of Women at Workplace Act, 2013' at SD Memorial School, Gurugram. Over 100 faculty and staff members attended, gaining insights into the crucial POSH Law, which aims to combat sexual harassment in workplaces worldwide. The workshop was conducted by Prof. (Dr.) Archana Sarma, Dr. Unanza Gulzar, Ms. Arushi Anthwal and Mr. Himangshu Rathee. The team addressed the participants as law experts and assisted them in understanding what qualifies as sexual harassment at the workplace and how the law redresses the same via both formal and informal redressal mechanisms as prescribed under the POSH Act.

10. National Workshop on "Creating a Multi-disciplinary Research Environment in HEIs" on 23 & 24 May 2023

A two-day National Workshop on "Creating a Multi-Disciplinary Research Environment in HEIs" was held in the University on 23 and 24 May 2023. The inaugural session of the Workshop was held in the Auditorium from 10:30 AM to 11:30 AM on 23 May 2023. Dr. Pankaj Mittal, Secretary General, AIU and Dr. G.S. Bajpai, Vice Chancellor, NLU, Delhi were the Chief Guests at Inaugural and the Valedictory functions respectively.

11. Signing of MoU's

(a) MoU with Seamedu

The NorthCap University signed an MoU with Seamedu - School of Expressionism, bringing together two academic powerhouses. - Research Exchange/Laboratory Internship programme, of 8 days upto 1 year, for B.Tech 3rd Year, M.Tech and PhD students from NCU. These programmes offer an incredible chance for the students to immerse themselves in the rich academic environment of SIT and gain invaluable international exposure.

(d) MoU with Santa Clara University - 23.06.2023

NCU signed an MoU with Santa Clara University (SCU). The Vice Chancellor, Prof. Nupur Prakash signed the MoU on behalf of NCU in the presence of Dr. Toby Mcchesney, Vice Provost for Graduate Programs, Santa Clara University. This collaboration paves the way for exciting opportunities and unparalleled benefits for the students of NCU:

- Annual Application Fee Waivers for all applicants
- Two Annual Scholarships of US \$9000 for Applicants in Under-represented Candidates in Engineering
- Two Annual Scholarships of US \$12000 for Applicants in Business
- GRE and GMAT waived off

This MOU marks the beginning of an inspiring journey of knowledge exchange, cultural enrichment, and transformative growth between NCU and Santa Clara University.

(e) MoU with NGO's NeoFusion Creative Foundation & Sansarino Development Foundation

The NorthCap University has entered into Memorandums of Understanding with two NGOs, Neofusion Creative Foundation and Sansarino Development Foundation on 29.05.23. Through these MoUs, NCU's psychology students will be able to collaborate on internships, placements, and live projects and gain practical experience. Registrar NCU, Cmde. ITEM NO. 11: FINANCE COMMITTEE RELATED MATTERS

(Member Secretary)

The Finance committee related matters discussed and approved during the last Finance Committee meeting were updated to the members, and the Minutes of the Finance Committee meeting held on 17 August 2023 is enclosed as **Annexure 15.**

All Members of the Board of Management took note of the above and approved the aforesaid Finance Committee related matters.

ITEM No. 12: ANY OTHER MATTER WITH PERMISSION OF THE CHAIR.

Following points were discussed with the permission of the Chair:

1. Repeated breach of Exclusivity of use of ASU Logo/ Marks in the 'Territory'. There have been frequent instances in the recent past of advertisements in newspapers by private universities located in Gurugram, which have featured the ASU Logo/ Mark in their advt., which is a breach of the exclusivity rights of NCU under the NCU – ASU License Agreement of February 2021. A five-member committee to be constituted comprising Prof. Manoj Kumar Gopaliya and 04 others, to examine the issues pertaining to the breach of exclusivity rights over use of ASU Logo/ Marks by other universities in the 'Territory' in terms of the License Agreement between NCU and ASU, and what needs to be done to stop these occurrences. The Committee to submit its report with firm recommendations by 10th September 2023.

- 2. The issue of 'non approval' of new programmes needs to be taken up with the Department of Higher Education, Govt. of Haryana. Firstly, why is it that Private Universities of Haryana need to take approval of the State Govt. for commencing new programmes. Is this applicable to State Public universities as well. If not, then it is discriminatory in nature, given that the private universities are also UGC approved, and therefore have been assessed to be capable of offering degrees in chosen programmes, and hence should have the freedom to run programmes of their choice, based on market requirements and other factors as may have been assessed by them. The present stance of the Govt. of Haryana runs contrary to the basic tenets of NEP 2020. Secondly, in case a particular program(s) has not been approved by the State Govt, then reasons for the same should be provided to the university, so that shortcomings if any can be addressed and overcome by the university.
- 3. Reservation in Admission and Fee Concession as per provisions of Section 36 of Haryana Private University Act 32 of 2006 (as amended upto 10 May 2012). The university has been pursuing this matter with the DHE, Govt of Haryana vide several letters, but no reply has been received from the dept. A total of 23 letters (details at **Annexure 16**) have been written to the DHE, requesting for different percentage of students eligible for hundred per cent, fifty percent or twenty-five per cent fee concession [in terms of Section 36 of Haryana Private University Act 32 of 2006 (as amended upto 10 May 2012)], given that The NorthCap University has collaborations/ MOUs with several foreign/ international universities. The DHE is requested to examine the issue on priority and allow a different percentage of students eligible for hundred per cent, fifty percent or twenty-five per cent fee concession to The NorthCap University, as done for some other private universities of Haryana having collaborations with foreign universities.

There being no other points, the meeting ended at 1:45 pm with a vote of thanks to the Chair.
